# **COLLEGE HIGHLIGHT**

Harlan Vincent addresses the board and introduces himself as program coordinator of the fire program EMS, EMT, Wildland. He states the program is up 60% from last October. Many students expressed interest during Sophomore Day. Harlan introduces student Tomi Desota.

Ms. DeSoto, entered in 2019 Spring. She has been involved in fire since she was 18, when she volunteered in Grants, NM, she was the first female volunteer. She went on to attain her bachelor's in EMS and Master's in Organizational Learning from UNM. Her long-term goal is to better the education for emergency services in New Mexico, specifically distance education for rural communities. She expressed appreciation that ENMU-Ruidoso's program accepts certificates as credits. She said the program was attractive because it will help her meet her goals and the availability of distance education. The Board expressed appreciation for having a strong female role model active in the program and thanked Tomi and Harlan for their time.

# PRESIDENT'S REPORT

Dr. Carstens read highlights from the College Report, which include work each staff and faculty department has been working on since May.

#### CHANCELLOR'S REPORT

Chancellor Elwell reports that Ruidoso campus enrollments increased; appreciated representation of the institution. He informed the board that ongoing system policy updates were underway, with about 60% of the policies updated, with 8 more up for approval in December. He reported updates regarding HED, LFC and goals for the upcoming legislative session.

### **INFORMATION ITEMS**

- 1. Strategic Plan Update: Goal Two: Dr. Carstens provided an overview of the Strategic Plan Update. Brad provided feedback on the EMT program, saying it was doing great. Dr. Carstens noted that the college is continually working on expanding necessary programs and engaging local industry.
- 2. Local Bond Referendum: Steve Lestarjette commented on the success of the local bond referendum. He noted that the bond passed with more support than any district in the state, stating that the local community is taking ownership of the college. Chairman Treptow expressed his appreciation for how the bond was handled and suggested the college hang a "thank you" banner in response.
- 3. College Nexus Project Update: Dr. Carstens and Dr. Massey explained the progress in Phase I of the College Nexus Project. The construction contractor, Jaynes, was awarded the three contracts for the remodel, retaining wall and roof, for \$3 million. The board and Dr. Massey discussed some budget issues and revised timelines, to include accounting for the unexpected mold remediation setback.
- **4. FY20 Budget Adjustment Request:** Dr. Carstens presented the Board with the Budget Adjustment Request, per state requirements.
- 5. Legislative Capital Requests: Dr. Carstens expressed rationale behind the current Capital Funding request. He noted that administrators on the Capitol committee asked to put in more funding, so college is not piecemealing projects together over time. HED accepted the full amount of \$2.5 million in state bond, after the success of the local referendum.

3. Fermentation Sciences Program – Ryan Trosper discusses the need and rationale behind a fermentation sciences program, which was developed from focus groups. Mr. Trosper noted the value added agriculture and specific interest from the industry, including several state wine partnerships. Mr. Trosper explained the structure of the program, included in the board packet, and timeline for state approvals.

4. Construction Trades Program – Mr. Trosper discusses work with Mescalero Housing Authority and the Housing Building Association on jobs in home repair and new builds in the area. The reservation is having difficult finding qualified workers. ENMU-Ruidoso presented MOU to Mescalero School Board. The type of courses and industry would be valuable and students graduating from the program would be given preferential treatment for jobs. A Mescalero dual credit teacher will begin teaching courses. The program would offer classes in the evening and is financial aid eligible.

5. Wind Energy Program – Mr. Trosper presents the proposed Wind Energy Program. He notes that the college is looking at pre-apprenticeship, apprenticeship and AAS Model. The program focuses on OSHA requirements, electrical safety training, confined space and lockout and other specialization for advancement. Pattern energy requested incorporated cybersecurity within mechanical wind turbine need. Mr. Trosper explained the desire of meeting community need as quickly as possible and designing courses to be on the cutting edge of the workforce. Discussion with Pattern Energy and other partners are still ongoing. The program timeline is set to start in 2021, after approval from HLC.
