# CHANCELLOR'S REPORT

Chancellor Dr. Patrice Caldwell reported that the ENMU System would present to the New Mexico Legislative as a system during the special legislative session.

#### FOUNDATION REPORT

ENMU-Ruidoso Foundation Director Rhonda Vincent reported that the Aim High fundraiser grossed more than \$33,000.

# PRESIDENT'S REPORT

President Trosper noted that fall enrollment was down 13 percent, and that the college was working with ENMU-Roswell to hire a nursing instructor who will serve at ENMU-Ruidoso. He noted that Dr. Cynthia Orozco had published a new book, Agent of Change.

Report on Strategic Goal Work Ready, Coda Omness said that the college was offering an Alcohol Server certificate online, and the college was first to put the online course online. She reported that the college was offering a Pumps and Wells course at the request of the Village of Ruidoso.

President Trosper discussed plans to open the spring semester given the impact of the COVID-19 pandemic.

President Trosper and Dr. Karen Massey updated the CCB on advancement in Nexus Phase II renovations, and said April 1 is still the target date for substantial completion.

President Trosper said he expects the New Mexico Legislature to decrease state appropriations to colleges by five percent.

Steve Lestarjette gave an overview of results of the recent state Bond C referendum, which passed with more than 60 percent of the vote, and discussed plans to improve communication with rural communities in Lincoln County.

President Trosper reported that the college was the fiscal agent for a Carl Perkins grant which benefited area school districts.

President Trosper presented the CCB with a 2021-2023 ENMU System Operating Agreement which outlines the college's relationship with ENMU. The Operating Agreement is scheduled to be approved by the ENMU Board of Regents, then returned for approval by the ENMU-Ruidoso Branch Community College Board.
